
***Overview and Summary***

San Pawl il-Bahar Local Council is presenting its Quarterly Financial Report for the period January till end of September 2022. Recurrent expenditure is related to the services the Council is obliged to render in line with Section 33 of the Local Councils Act. A general overview shows that the Council kept to the Budgeted expectations for 2022.

The Council successfully ended the period with a positive indicator of 122% of it's annual government allocation. In acquiring this objective, the Council will keep an eye on its spending and avoid anything which is not in line with the Budget and the Business Plan. The Council has a reserved Fund for Local Council Building Development amounting to €900,000.
